For purposes of this award, in the following clauses, the term "contract" shall mean the resulting purchase order(s); the term "Contractor" shall mean "Seller"; and the term "Government" and "Contracting Officer" shall mean the "University of Maryland" and the "Director of Procurement and Strategic Sourcing" respectively. The University reserves all administrative, contractual, and legal remedies against the contractor who breaches any of the contract terms. It is intended that the referenced clauses shall apply to Seller, the legal entity which contracts with the University under any solicitation or purchase order, in such manner as is necessary to reflect the position of Seller as a Supplier to the University, Buyer and legal entity issuing a solicitation or purchase order; to insure Seller's obligations to the University and the United States Government; and to enable the University to meet its obligations under its prime contract or subcontract. The Contracts Disputes Act shall have no application to this purchase order, and nothing in this purchase order grants Seller a direct claim or cause of action against the U.S. Government. Any reference to a "Disputes" clause shall mean the "Disputes" clause of this purchase order. Seller shall include in each lower-tier subcontract the appropriate flow down clauses as required by the FAR and agency supplement clauses included in this purchase order.

The applicable dollar amount listed in FAR or agency supplement clauses indicates the dollar threshold at which the subject FAR or agency supplement clause becomes applicable to the contract and does not preclude other applicable FAR or agency supplement clauses. If a clause is not applicable based on dollar threshold it is hereby agreed that the clause will be unenforceable until such time as the threshold is reached.
